Pomona Chamber of Commerce selects Cathy and Victor Tessier as this year's Community Service award recipients. With the development of the Historic Fox Theatre as one of their major projects the Tessier family of Pomona continues to restore and refurbish downtown Pomona to benefit the community.

Victor and Cathy met and married in 1965 and settled in Pomona after earning their college degrees. Victor was practicing law and Cathy was teaching music part time for the Pomona Unified School district and the Mary B. Eyre pre-school in Claremont. She was also a charter member of the Preparing Expectant Parents, Inc. a non-profit parent education organization. They have three wonderful and accomplished children.

Edward the eldest besides being very

active in the family development and management business also advocates extensively for the disabled community. He and his wife, Alejandra has a three year old son, Victor. Vicki has been teaching specialized dance and performance classes also for PUSD for over twelve years. Jerry is the family developer, finding real estate projects that need the family's successful formula for development.

From 1967 to 1993 Cathy and Victor acquired over 400 multi-residential units in Pomona and Corona, which were in very bad condition. Cathy assumed the management and renovation and operations of the units and continues to this day.

They are also charter members of a group of community members, Fire Department officials, and Pomona City employees formed to establish an effective code

WIRELESS POMONA

Last year, the City embarked on transforming Downtown Pomona into a wireless network. Today, students, businesses, and residents are staying connected while enjoying Downtown Pomona.

As a result, the City will be expanding the high-speed wireless internet to the entire City. A Wireless Pomona Request for Proposal was sent out in mid March and completed six oral presentations from interested wireless vendors including Azulstar, Ltek, Calence/Cisco, Metrofi, Solutrea, and Cheetah/Tropos.

A Wireless Pomona Committee was formed to choose the top three finalists: Azulstar, Calence/Cisco, and Cheetah/Tropos.

A company will be selected this month and will begin the planning and deployment of a Wireless Pomona.

A Wireless Pomona will bring endless possibilities to the City. Pomonans will be able to stay connected while enjoying the quality of life in our community. It will also be a benefit to enhance government efficiency, promote economic growth, foster greater community satisfaction and bridge the digital

Wireless technology uses radio transmissions to connect computer devices to a network or to each other. Computer users beneath this wireless mesh canopy will be able to connect quickly and easily to the Internet at distances of up to about 100 yards. With a wireless network, users can surf the Web, access work files, and check email all without having to plug into a network or telephone jack.

With wireless Internet connections the City and our technology providers are making access to the Internet more reliable, economical and convenient for the students, businesses, and residents in the entire City. STREET IMPROVEMENT PROJECT ON RIO RANCHO ROAD

Pavement rehabilitation of Rio Rancho Road from Country Mile Road to Park Avenue is underway and will continue through mid-August 2007. Pavement rehabilitation will include extensive removal and replacement of existing asphalt concrete pavement, followed by an asphalt overlay of the entire street.

During the construction, Rio Rancho Road will be reduced to one lane in each direction. Construction hours are 7:00 a.m. to 4:00 p.m. weekdays and night work will take place at the Rio Rancho/SR71 overpass as required by the Caltrans Encroachment permit.

enforcement program for the city. In 1977 the Tessiers also organized the Pomona Southwest Council, a group of property owners and managers to address extreme property blight in South Pomona.

Gloria Molina Announces Elimination Of Unsafe Railroad Crossing in Pomona

L.A. County-ACE-Pomona Deal Will Reduce Traffic, Noise

LOS ANGELES (June 19, 2007)—Los Angeles County Supervisor Gloria Molina announced today that an unsafe railroad crossing in Pomona will be virtually eliminated thanks to a land deal worked out between the county, the City of Pomona, and the Alameda Corridor East (ACE) Construction Authority.

“Anyone living or working near this railroad crossing suffers from the noise, traffic congestion, and safety hazards these trains produce every single day,” Glolina said. “That will change how that through freight train use is on its way to being virtually eliminated =ere. I am proud that all parties involved in this deal—L.A. =st1:PlaceType w:st="on">County, ACE, and the City of Pomona—were able to come to an agreement and, in doing so, improve the daily lives of the people of Pomona.”

At today’s weekly meeting of the Board of Supervisors, Molina and her colleagues authorized a \$332,000 sale of approximately one acre of excess South San Jose Creek Parcel property owned by the L.A. County Flood control District to the ACE Construction Authority. The land is adjacent to existing Union Pacific railroad tracks in Pomona. Construction is underway and is scheduled to be completed by early 2008.

Over the past decade, as economic activity in the San Gabriel Valley has increased, so has vehicle and rail freight traffic. =/SPAN>Train traffic in the San Gabriel Valley is expected to increase to 160 trains per day by 2020. Localized economic growth is projected to increase local traffic volumes by almost 40 percent over the same period.

As a result of these trends, crossing gate blockage time is expected to increase 54 crossings in the San Gabriel Valley. Expected auto and truck vehicle delay would increase by 300 percent between 1994 and 2020 unless something is done.
